Procedure for application of the mark of conformity of the System of voluntary certification of products and services "RusQuality-Halal"

1. General requirements

- 1.1 Objects of certification certified in the System of voluntary certification of products and services "RusQuality-Halal" (hereinafter the System) may be marked with a sign of conformity of this System.
- 1.2 This Procedure establishes the form, description of the Conformity Mark of the System, as well as methods and place of its marking.
- 1.3 The conformity mark of the System is a form of communicating to the consumer and other interested parties' information about the manufacture of products (provision of services) in compliance with the requirements of the System.

2. Regulatory References

The following normative references are used in this Procedure:

GOST R 1.12-2020 Standardization in the Russian Federation. Terms and definitions (Standardization in Russian Federation. Terms and definitions);

GOST 1.1-2002 International Standardization System. Terms and definitions".

3. Abbreviations and acronyms

The following designations and abbreviations are used in this Procedure:

Halal - translated from the Arabic language as "permitted";

System - System of voluntary certification of products and services "RusQuality-Halal".

4. Form, description of the system conformity mark

- 4.1. The idea of the System Conformity Mark is a graphic image serving to inform purchasers of the conformity of objects certified in the System to Halal requirements.
 - 4.2. The graphic representation of the System Compliance Mark is circular.
- 4.3. The mark of conformity of the System is a circle of green color with additional elements: the outer side of the circle, the inner circle with a light green crescent and the image of a star, the word "Halal", white color, in three languages: Russian, Arabic and English and lower semi-circular tri-color band of white, blue and red. On the outside of the circle in green are the words "Certified by the Russian

Quality System," in three languages: Russian, Arabic and English.

4.4 The image of the System Compliance Mark is given in Appendix A of this Procedure.

5. The order of application of the conformity mark of the System.

- 5.1. The right to apply the conformity mark of the System is presented to the applicant based on the following documents:
- contract for certification, concluded in the prescribed manner with an autonomous non-profit organization 'Russian Quality System'
- certificate entered into the register of the System;
- permission to use the Mark of Conformity of the System.
- 5.2. The form of the System Conformity Mark Authorization Form standard is provided in the form of Appendix K of the System Operational Rules.
- 5.3. Documents for granting the right to use the Conformity Mark of the System shall be issued by the Certification Body of the System. The right of application of the System Conformity Mark cannot be granted on the basis of the documents submitted by the applicant.
- 5.4 Marking with the Conformity Mark of the System is carried out by the manufacturer at his own expense.

6. Technical requirements

- 6.1. Marking of certified products with the System Compliance Mark must be recognizable, the image easily readable, while signs, symbols must be contrasting to the background, on which the marking is applied.
- 6.2. The full-color image of the System Compliance Mark is used for marking products if there are no restrictions on the quality of printing, in the design in the points of sale, when placed on the Internet and in other materials in electronic form, in the design of signage and other promotional products.
- 6.3. The conformity mark of the System, in the form of graphic image, shall be placed on product packaging, in any place accessible for consumers
 - 6.4. The conformity mark of the System may be placed:
 - on consumer and/or transport packaging with finished products in the course of the technological process of its production;
 - for liners inserted into each unit of consumer and/or transport containers with finished products;

- for labels attached to each unit of consumer and/or transport containers with finished products;
- for stickers, labels, counter labels, collars. glued on the consumer packaging with finished products;
- -- for accompanying documentation.
- 6.5 The image of the System Mark of Conformity must retain a clear and distinct graphic during the whole shelf life of products.
- 6.6 Distortion of proportions, elements of the System Compliance Mark and change of color scheme of the Compliance Mark is not allowed.
- 6.7 The minimum size of the image of the System Mark of Conformity is 10 mm, including the security field.
- 6.8 Reproduction of the System Compliance Mark may be performed in larger scale.
- 6.9 The System Compliance Mark shall be optically aligned in size when placed together with other signs.
- 6.10. For application of the System Compliance Mark, the main color of the package/sides of the package should be chosen. The mark must be visible, clear and contrasting. If there is no possibility of application of the Mark of conformity of the System in full color model, the image of the mark is used under printing limitations.
- 6.11. Marking with the System Compliance Mark can be made in one of the ways:
 - typographic;
 - lithographic;
 - by printing;
 - by stamping;
 - by punching;
 - branding;
 - by other methods available and safe for the consumer.
- 6.12. The image of the System Conformity Mark shall be clear with distinguishable individual elements.
- 6.13. When marking Halal products it is not allowed to apply separate elements of the image of the Mark of Conformity of the System.
- 6.14. Products (services), which are not certified and/or do not meet the requirements of the System, may not be marked with the Mark of Conformity of the System.

6.15. Upon expiration of the term of validity of the certificate of conformity, the holder of original certificate of conformity shall be obliged to stop using the Mark of Conformity of the System.
